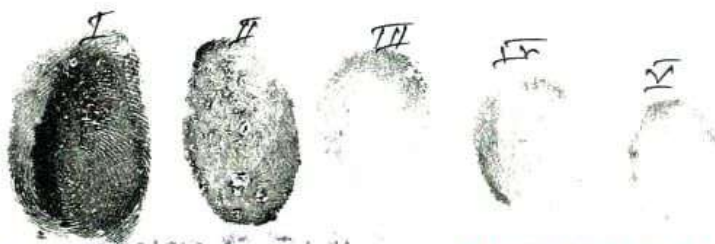

Objective of the Trust :-

1. To maintain and look after the Trust property.
2. To ensure the performance of the institutions of the trust.
3. To engage Teacher and other staffs for the institution who shall be efficient to perform his duty according to the regulations of the institution.
4. To hold and organize functions on approved time regularly.
5. To Collect offerings which may be made by the persons or/and organizations and to keep the same under proper care and custody.
6. To expand the institutions if it is felt necessary.
7. Sri Uma kant Tiwari shall be managing Trustee so long as he remain alive or capable to manage his affairs as the managing Trustee. Thereafter his wife Snchita Tiwari shall be managing Trustee or the

8. Power of the Trust shall be exercised by the Managing Trustee in consultation with the other Trustees. But if any differences is arisen amongst the Managing Trustee and other members of the TRUST then the majority shall prevail.

Besides the above the power and duty of the Trustees shall be as under.

- (a) The Trustees shall for the sake of convenience constitute sub committees for proper management and maintenance of the Trust property and carry out objective of the Trust.
- (b) The trustees shall not entitled to collect money from the ~~public~~ without authority.
- (c) All expenses shall be born by the income of the trust or the donation amount received by the trust.

- (d) The Trustees shall engage/employ Qualified persons as per their discretion as they think fit for the performance of the institutions on such salaries or pay or as they think fit and also be entitled to suspend and remove them and in their place appoint others to work. Provided that before appointing the new one the Trustees shall obtain consent from the Founder of the Trust and only on his expressed consent in consultation of other trustees such person and /or the employee shall be appointed.
- (e) The Trustees have no power to borrow money from the Trust. However the Founder of the Trust can delegate the power to one or more trustee for the same.
- (f) The Trustee may invest the money and properties in the Trust for the expansion or

- (g) The management and control of the Trust Property is vested in the Trustees but the management shall be done only on the instructions and directions of the Founder of the Trust.
- (h) On the death of any of the Trustee the senior most member of his family will be substituted on his /her / place.
- (i) Be it noted that the present Trust shall continue to be a family Trust.
- (j) The Founder of the Trust may at any time or times here after by any deed or deeds revocable or irrevocable or by will or conduct expressly referring to this power or the property subject there to appoint such new or other trustees and
